

OFF-LICENCE RENEWAL

Sale and Supply of Alcohol Act 2012 - Section 135

To KINA BEACH ENTERPRISES LIMITED

The off-licence in respect of the premises situated at **21 Dee Road, Kina Peninsula** and known as "**Kina Beach Vineyard**" is renewed. Pursuant to the Sale and Supply of Alcohol Act 2012, **KINA BEACH ENTERPRISES LIMITED** is authorised to sell and supply alcohol on the premises to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act. The present conditions of the licence continue to apply. These are as follows:

CONDITIONS


1. HOURS: Alcohol may be sold only on the following days and during the following hours:
 - (a) **Monday to Sunday 8.00 am to 6.00 pm**
 - (b) A remote sale of alcohol may be made at any time on any day. Alcohol must not be delivered to the buyer between 11.00 pm and 6.00 am the next day, on Good Friday, Christmas Day, or before 1.00 pm on Anzac Day.
 - (b) No alcohol is to be sold on or delivered from the premises on Good Friday, Christmas Day, or before 1.00 pm on Anzac Day.
 - (d) No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made—
 - (i) on the premises; or
 - (ii) from grapes or fruit harvested from land on which the premises are situated
2. RESTRICTIONS:
 - (a) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed.
 - (b) The licensee must take reasonable steps to verify that the buyer of any alcohol, sold by remote means, is not under the purchase age.
3. WATER: While alcohol is being supplied free as a sample, free drinking water must be provided for customers at the tasting location.
4. DESIGNATED AREAS: The whole of the premises is designated as a Supervised area. The defined area is the area outlined on the plan received 8 August 2022.
5. SIGNAGE: Signage must be displayed at each point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons. The licence holders name, the licence number and the date on which the licence expires must be displayed on any internet site for remote sales, in any catalogue and printed on every receipt issued for alcohol sold remotely.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence expires on
